

**PRIMETIME SPORTS ABILENE LLC PARENTAL CONSENT RELEASE
AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY
AGREEMENT**

IN CONSIDERATION OF my MINOR being permitted to participate in or be present in any way for the PRIMETIME SPORTS ABILENE LLC ACTIVITY that my MINOR is **REGISTERED** for (herein referred to as ACTIVITY) I the MINOR's parent or legal guardian, for myself for personal representatives, assigns, heirs, next of kin, and spouse (if I have one):

1. ACKNOWLEDGE, AGREE, AND REPRESENT the nature of ACTIVITY and that my MINOR is qualified, in good health, and in proper physical condition to participate in such ACTIVITY. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue my MINOR's further participation in the ACTIVITY.
2. FULLY UNDERSTAND THAT: (a) ACTIVITY INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS") for my MINOR; (b) these Risks and dangers may be caused by my MINOR's actions or inactions, the actions or inactions of others participating in the ACTIVITY, the condition in which the ACTIVITY takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I, on my MINOR's behalf FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES that my MINOR may incur as a result of my MINOR's participation in the ACTIVITY.
3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE PRIMETIME SPORTS ABILENE LLC, their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the ACTIVITY takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, my MINOR, or anyone on my MINOR's behalf, makes a claim against any of the Releasees, I and my MINOR WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS FOR MYSELF AND FOR MY MINOR BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT I FULLY UNDERSTAND THAT THIS PRIMETIME SPORTS ABILENE LLC PARENTAL CONSENT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT APPLIES TO THE MINOR OR MINORS LISTED IN THE FOLLOWING TABLE:
